Frequently Asked Questions (FAQ)



- **I have been nominated to become an ESC Fellow (FESC) in 2027. What does it mean?**

Your Cardiac Society President has attested that you are a professional who meets the ESC Fellowship criteria in full and best represents the scientific, clinical, or nursing & allied professions *excellence* in cardiovascular medicine. Therefore, **you have been elected to become a FESC in 2027 via the *Presidential Nomination* process.**

FESC nominees should formally declare to their Cardiac Society President (once they are notified of their nomination), their willingness to maintain and honour their FESC status in the long term. This commitment involves contributing to ESC activities and making an annual payment of the FESC fee.

- **What does the title 'Fellow of the European Society of Cardiology' mean?**

The title 'Fellow of the European Society of Cardiology' (FESC) honours individuals who have distinguished themselves in cardiovascular medicine. A unique and prestigious title, the ESC Fellowship programme recognises globally excellence and lifetime achievement in cardiology.

- **When do I have to pay the FESC fee?**

The yearly FESC fee covers the period from 1 January to 31 December (year N+1). Check your MyESC account to know the FESC fee. Newly elected FESC receives the request for payment in November (year N).

The annual FESC fee covers the period from 1 January to 31 December of the following year (N+1). To find out the specific FESC fee, please refer to your [My ESC account](#). Newly elected FESC receive the payment request in December of the current year (N).

The request for payment is mailed, and the payment must be received before 30 December (Year N) to ensure delivery of the selected Journal early January (year N + 1).

Once the fee is paid, new FESC start to benefit from the [FESC privileges](#).

- **When will I get my registration confirmation/invoice?**

Once your nomination has been submitted, you will receive an ESC in November of the current year (N). You will be officially welcomed and invited to pay for your annual FESC fee. Once your FESC fee is paid your ESC Fellowship will be activated for the year N, covering from 1 January to 31 December.

You will be sent a registration confirmation by email (it can take a few minutes to come through; if you did not receive a confirmation email, please check your spam folder).

A receipt is available in your ["My ESC account" under "My Orders"](#) > "Details" a few minutes after payment.

An invoice will be available in the same place within 24 hours.
